Sub: e-Freight Initiatives at Air Cargo Complex, CSIA....reg

This is with reference to the implementation of E-Freight initiatives by Mumbai International Airport Pvt Ltd (MIAL) at CSI Airport, in continuation to our earlier circulars we are pleased to inform the EXIM Trade that GMAX is being implemented for Perishable Cargo Terminal Operations w.e.f 01st Dec 2018 at CSI Airport.

All freight forwarders operating at CSIA through Perishable Cargo Terminal (PCT) operated by M/s Mumbai Cargo Service Centre Cold Chain Solutions Pvt Ltd are hereby required to send the advance shipment information viz Master Air waybill / House manifest (summary of House Air waybill) – details through GMAX (www.gmax.gvk.com), as done for General Cargo. This will enable the further process of on-line carting request, generation of Export TSP and dissemination of information to other stake holders.

Freight Forwarders / Customs Brokers already registered with GMAX and holding PD Account with M/s. Kale Logistics for general cargo transaction need not register again / open PD Account. They can navigate to CSC-PER tab after login with existing user credentials for carrying out transaction of perishable cargo terminal. The new / fresh users are requested to register with GMAX at www.gmax.gvk.com and open PD Account for ASI with M/s. Kale Logistics for effecting smooth perishable cargo transactions at CSIA.

All concerned are hereby advised to make note of the same and disseminate to all users of Perishable Cargo Terminal. The following are benefits:-

- 1. On-line registration of MAWB and HAWB for e-booking with airlines
- 2. Request and Approval of Carting Order On-line
- 3. Payment of Export TSP On-line
- 4. Generation of Vehicle Token On-line
- 5. Forwarding of FWB /16 and FHL/4 to the airlines
- 6. Generation of Freight Forwarder / Customs Broker monthly statement
- 7. Complete track and trace of the freight status update
- 8. Enhanced security system with stronger login
- 9. Auto intimation of weight difference to the carriers

The system will go live with effect from 01st Dec 2018, therefore all Freight Forwarders / Customs Brokers are required to submit the Advance Shipment Information (ASI) for all shipments handled through PCT. Online TSP along with Vehicle Token will be generated only after the receipt of ASI for the shipment. All other process remains the same as done for the general cargo transactions through GMAX.
